The Employee Retention Credit (ERC) is a payroll tax credit that was passed as part of the 2020 Cares Act (stimulus program) designed to bolster those businesses that we're able to retain their employees during the pandemic. Due to the extremely complex tax code and qualifications, it is severely underutilized. Details of the program include:

The eligibility requirements for ERC are as follows:

Your business experienced a partial or complete suspension of operations. This includes:



Here's how it works:

1. Your business is pre-qualified by ERC Specialists.
2. ERC Specialists will quickly inform you how much you can receive
3. You'll submit your payroll tax returns and PPP information, if applicable.
4. Our team of specialists will maximize your Employee Retention Credit and submit your application to the IRS.
